The Board of Directors of Rompetrol Rafinare S.A. hereby informs its shareholders and any potential investors about the decision subject to which Rompetrol Rafinare S.A., Rompetrol Downstream S.R.L., KazMunayGas Trading A.G. and KMG Rompetrol S.R.L. intend to enter during the next period of time into a syndicated revolving credit worth USD 390 million, such amount being intended to refinance certain previous loans but also to support the current operations and activities of the said companies.

This loan is a multi-currency facility (USD, RON or EUR) granted by Banca Comercială Română, UniCredit Tiriac Bank, Raiffeisen Bank, ING Bank NV - Bucharest branch. This loan cannot be used by the 4 companies of KMG International (garantor in this loan) for long-term financing of investment projects, acquisitions and/or leases.

The loan will consist of two tranches, namely a comitted facility of up to USD 240 million, valid for 3 years and an uncommitted facility of up to USD 150 million valid for one year as of the contracting date thereof. Subsequently, the term of the uncommitted facility may be extended for a period of 3 years as of the execution date of the Credit Facility Agreement.

Active in 12 countries, KMG International is one of the most well-established oil companies in Romania and a key player in the Black Sea and Mediteranean areas, carrying out major refining, petochemicals, retail, trading, upstream and industrial services operations. At international level, KMG International holds and operates more than 1,000 fuel distribution stations spread in six countries (Romania, France, Spain, Bulgaria, Moldova, and Georgia). KMG International is fully owned by the national oil and gas company in Kazakstan – KazMunayGas.
