*Investor information - litigation of Rompetrol Rafinare, alongside KMG International NV and Oilfield Exploration Business Solutions SA, case file no. 225/D/P/2006*

Rompetrol Rafinare S.A. informs its shareholders that, on July 10<sup>th</sup>, 2020, the High Court of Cassation and Justice has dismissed as inadmissible the complaint filed by SC Balkan Petroleum SA and SC Faber Invest & Trade Inc against the Order issued by DIICOT on 05.12.2019 by which was closed the Criminal case file no. 225/D/P/2006.

By the same Decision, the High Court of Cassation and Justice has dismissed as unfounded the joint complaint filed by Rompetrol Rafinare, KMG International NV and Oilfield Exploration Business Solutions SA against the Order of 05.12.2019.

We remind that by the Order of 05.12.2019 was ordered the keeping of a precautionary measure on 4 installations of the Company up to the concurrent coverage of the amount of USD 106m which will cease ipso jure if the Authority of Valuation of the State Assets– AAAS and Faber Invest will not bring action before the civil court within 30 days from the notice of the court’s ruling.


Whereas AAAS has not filed, within the term mentioned hereinabove, a civil action against the Company, and Faber’s civil action was annulled as unstamped by the Bucharest County Court, the Company will make use of all legal means available in order for these precautionary measures to be lifted.
