Production Plan for PEM – 2024

TOTAL THROUGHPUT: 4,956,092 mt out of which: 4,649,773 mt crude oil, 306,319 mt other feedstock.

1. Feedstock

The types of feedstocks planned to be processed in 2024 (mt/year):

- KEBCO: 2,958,490

- Azeri Light Crude Oil: 1,101,152

CPC Crude Oil: 590,131

Crude unit throughput: 4,649,773 mt/year (14,951 mt/day for 311 processing days).

Density and Sulphur (average value) for Crude unit throughput resulted after PIMS simulation: 0.8586 g/cm3, 1.21 % wt sulphur content.

2024 White Products yield is 85.85 % wt.

Note: Regarding: raffinate, C5-C6 cut, hydrotreated kerosene, slurry, fuel oil and fuel oil type I marked, these products will be transfered to Vega Refinery to be processed in order to obtain valuable products.

Auto fuels are sold on domestic market to Rompetrol Downstream (Gasoline Europlus 10 ppm, Gasoline Efix 95, Gasoline Efix S 98, Gasoline RON 98, Super Diesel Euro 5, 51 Efix Diesel, 55 Efix S Diesel, 55 Diesel) and also to Socar Romania, Mol Romania and OMV-Petrom.

The other products are sold on domestic market through: Rompetrol Gas, Air BP Sales, OMV-Petrom, Eurospeed, Eurogenetic, MApN, Heidelbergcement, Lafarge and Romcim. On the export market the products are sold to: KMG Trading (Bulgaria, Georgia, Ukraine, Serbia, Greece, Türkiye, Israel, Egipt), Rompetrol Moldova, Rompetrol Georgia, Rompetrol Bulgaria, Ungaria şi alţii.

Auto fuels are sold 56.5% on domestic market and 43.5% on export market.

3. Unfinished products

The production plan was done without consumption/accumulation of unfinished products.

4. Products Specifications / Technical Assumptions

Gasoline production for domestic market contents min. $8.0\%\ v/v$ Bioethanol according with internal reglementation.

Diesel production for domestic market contents min. 6.5% v/v Biodiesel according according with internal reglementation. Rompetrol Rafinare is producing Diesel 55 with the highest cetane number from Romania market.

According to the new regulation the diesel production for domestic market has to contain min. 0.2% vol of 2nd generation biodiesel.

For 55 days (during 10th of March and 3nd of May) Petromidia Refinery will be shutdown in order to perform the General Turnaround activity. During the Turnaround period are planned: to be replaced all the catalysts from refinery units, without 121 Kero Hydrotreater (particle guard only) and HPP (R301), to be executed mechanical works, ISCIR activities and also implementation of CAPEX projects in 125- Diesel Hydrotreater (acquisition and install of two new reactors), Hydrogen Production Plant, Naptha Hydrotreater and Delayed Coker Unit (replacement of the coke drilling-cutting system) in order to improve operational results and increase energy efficiency.

2024 Plan for Production activity Rompetrol Rafinare

Vega Refinery

The main assumptions for production plan and sales plan 2024

1. Feedstock

Vega refinery will process raw material from Petromidia Refinery: C5-C6 Cut, Raffinate, Hydrotreated kerosene and Fuel oil.

The production plan was built considering the availability of the raw material transfer from Petromidia which are influenced by the 55 days of shutdown due to General Turnaround, between 10th of March and 3rd of April.

In Vega Refinery the turnaround periods were scheduled according to the General Turnaround from Petromidia, in order to minimize the influence on production. Thereby, Hexane unit and Rectification unit turnarounds are scheduled between 8th and 19th of April and Dearomatisation unit turnaround is scheduled between 12th and 23rd of April. For the DV and Bitumen units the turnaround was planned between 12th and 23rd of February, due to seasonal market demand.

Between 11th and 15th of March is scheduled the energetic turnaround.

The total feedstock for 2024 will be **413,137** tonnes in the following structure:

- C5-C6 cut 66,390 tonnes
- \circ raffinate 200,295 tonnes
- o hydrotreated kerosene − 10,000 tonnes
- \circ slurry 6,725 tonnes
- o fuel oil 129.658 tonnes
- \circ marker 15 tonnes
- \circ polymer 55 tonnes

In 2024 White Products yield is planned to be 65.7 % wt.

The production plan for 2024 was built considering a higher valorification of the raw materials, through the finish products obtained and an efficient work, without accumulation of unfinished products.

Vega refinery is the only east European producer of N-hexane, used in polypropylene production and extraction of vegetable oils in food industry.

Vega refinery is also the only romanian producer of Ecological Solvents – Rompetrol SE, products with lower sulphur and aromatics content and lower toxicity level.

3. Products Specifications

The finished products for Vega Refinery are produced according to Quality Specific Standards that are in use at the moment and comply with the internal and international standards for these products.
