Important event to report: *Finalization of litigation between Rompetrol Rafinare S.A. as plaintiff, in conflict with the General Directorate for the Administration of Large Taxpayers and the Romanian State through the Ministry of Finance represented by the Ministry of Finance through the Regional General Directorate of Public Finance Galati, the County Agency of Public Finance Constanta, as defendants and Balkan Petroleum S.A. as intervener*

Pursuant to the provisions of art. 234 letter l) of A.S.F. Regulation no. 5/2018 regarding issuers of financial instruments and market operations, Rompetrol Rafinare S.A. informs its shareholders and investors that, according to the information published on the court portal (<https://portal.just.ro/>), the High Court

of Cassation and Justice, as the court of appeal, has decided the following on File no. 253/36/2021*:

Rejects the appeals declared by the appellant-defendant National Agency for Fiscal Administration and by the appellant-defendant Romanian State through the Ministry of Finance represented by the Regional General Directorate of Public Finance Galati, the Administration of Public Finance Constanta County against Civil Sentence no. 32 as of February 5, 2024, pronounced by the Court of Appeal Constanta - Administrative and Fiscal Litigation Section, as unfounded. The solution is final.

By Civil Judgment no. 32 as of 05.02.2024, the Constanta Court of Appeal admitted the summons filed by Rompetrol Rafinare and obliged the defendant, the National Agency for Fiscal Administration - General Directorate for Large Taxpayers Administration to issue the Decision to lift the precautionary seizure established on the assets of ROMPETROL RAFINARE SA by the Decision to establish precautionary measures no. 1059301/10.09.2010 and the Decision to revoke the Enforcement Title no. 8993/17.11.2010.
