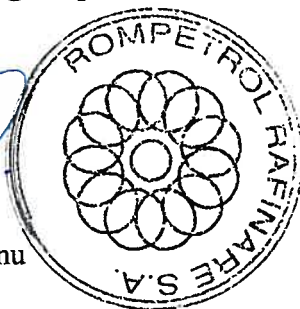
The aforementioned reports shall be transmitted to the Bucharest Stock Exchange and Financial Supervisory Authority according to the legislation in force.
